MINUTES OF THE MEETING HELD ON MONDAY 11th MARCH 2019

Minutes of the Town Council meeting held on 11th February 2019: The Council resolved to approve the minutes as a true record of the meeting and they were signed as such by the Chair. **Updates** from minutes (not covered elsewhere on the agenda): 223.1 **Youth Shelter** – to consider a police request to paint the Youth Shelter roof with anti-climb paint: The Clerk informed Council of the costs and that the Grounds Maintenance Contractor was willing to carry out the work. The Council resolved to approve the painting of the Youth Shelter with anti-climb paint and to put up Warning signs. **Reports of recent activity:** 224.1 **Reports from external body meetings attended by Town Councillors:** Cllrs Coates, Mollard and Hallett attended a Twinning meeting. Cllr Coates attended a meeting to organise the Scouts and Guides Festival. Cllrs Coates and Hallett attended the RAFA AGM. Cllr Coates attended Mowbray school where she gave a talk about the work of a town council and councillors. Cllrs Noone, Mollard, Hallett and Barningham



attended a Bedale and Villages Community Forum meeting. Cllrs Noone, Mollard and Barningham attended two Tour de Yorkshire meetings. Cllr Mollard attended a Y L C A meeting. Cllr Hallett attended a meeting to discuss the Freedom of Bedale with RAF Leeming, and the Mayor of Colburn's charity dinner.

224.2 Report from District/ County Councillors:

District Cllr Noone informed the Council that Community Infrastructure Levy monies had no restrictions on usage - i.e. ClL could be used to gain revenue or used as a joint venture with other bodies.

Cllr Carl Les from North Yorkshire CC reported that the county council had agreed the protocol for Vehicle Activated Signs, with the cost being in the region of £2,500 and information on purchase, installation and maintenance available from NYCC early in the next financial year

224.3 Report from NY Police representative:

PCSO Ian MacDonald handed out and presented the report. (See Appendix A). PCSO McDonald informed the Council that there had been anti-social behaviour issues over the last weekend and as a result there would be extra foot patrols in place to address this. Also, that on Saturday 16th March at Bedale Fire Station the Police are to hold property marking sessions which was open to the public. There was a possibility of attending a Saturday Car Boot Sale to carry out property marking in Bedale Park for the public.

225.1819 Financial statement and approvals for payment:

The Council **resolved** to approve the following payments: Salaries (Clerk/Assist Clerk/Market Superintendent/Caretaker); Paul Ellis (bus shelter/bandstand) £60; E & P Electrics (Xmas lights) £2591.90; Chris Monkhouse (painting posts & chains on Wycar) £1000; TWC Facilities Ltd (toilet tissue) £37.20; Bedale Hall (heating charges) £162.36; Yorwaste Ltd (car boot sales waste collection) £1512.58; JA Cockburn (cleaning supplies for toilets) £8.48; Bedale Print Shop Ltd (office stationery) £10.48; HMRC (PAYE/NI qtr 4) £777.01.

226.1819 Liftshare – to receive a short presentation about expanding local liftshare schemes to Bedale as part of a North Yorkshire-wide scheme.

Sharon Cooney, a liftshare project officer funded by North Yorkshire CC, gave a brief outline of her role and her aspirations for Bedale. She explained how the scheme worked in Masham, and that this was an online lift matching scheme by which users can simply input the journey date/ time and location and bne matched with other users. Her aim was to expand the system county-wide, including in the first instance Bedale and Ripon and surrounding areas to link up with the success of Mashamshire.

In response to councillors' questions about how the town council could assist the scheme, Ms Cooney said that she was looking for support from the Council in principle and may put forward a proposal for financial support to help produce and distribute leaflets explaining the scheme.

The Council **agreed** that they were willing to support the scheme and add a link onto the Council's website.

ACTION: Clerk to liaise with Liftshare

227.1819 Tour de Yorkshire – to receive an update on preparations and consider any policy or practical decisions necessary at this stage.



	The Clerk reported that at the last Steering Group meeting North Yorkshire Highways gave details of the road closures and a draft timetable was issued; the women's race to finish between 12.30-12.55pm and the men's race to finish between 5.45-6.05pm. The Steering group has the use of the finishing straight, podium and public address between 1.30-3pm and a variety of inclusive events are planned. Parking would be suspended on Market Place / North End from 6pm on the previous night and the roads would be closed on the day until after the race finish. The Council would receive confirmation of the road closures by the end of March. The young children's souvenir had been agreed as a water bottle, this would be issued to all pupils at Bedale Primary School and primary-age pupils at Mowbray School. There would be a "Ride the Route" 20-mile cycle ride to finish on the Market Place at 3pm and also a decorated "bike parade" through the town. The day will end with a concert in the Park at night as a thank you to residents. The Clerk presented an event budget to the council for TdY activities and the Council resolved to approve the budget presented.
228.1819	Section 106 – to note the approval by Hambleton DC or re-allocating Section 106 monies for children's play from Burrill Road to Bedale Park, and to consider options for new equipment/facilities. The Council resolved to set up a working group consisting of Cllrs Coates, Mollard and Barningham. This group will look at play equipment options in Bedale Park, including through consultation of local young people and the general public.
229.1819	Scouts and Guides Festival – to receive information about the Bedale Scouts and Guides Festival on Sunday 9 th June 2019. Cllr Coates explained that the group are currently finalising plans; there will be a parade through the town and this year's theme was superheroes". RAF Leeming had been booked along with the air cadets and vintage cars.
230.1819	 The Wynd/Wycar Green traffic – to consider a proposal to lobby NYCC Highways with a view to making into no through roads. Following comments from members of the public that large lorries were using the road as a "cut through" to get to Masham, councillors considered suggestions including making the roads no through roads, imposing a 7.5 ton weight restriction except for access, and making the roads one-way from Masham Road towards Market Place. ACTION: Clerk to contact NYCC Highways to request assistance on any or gall three of these suggestions.
231.1819	Friarage Hospital – to consider a response to proposed changes to critical care services at the Friarage, and to a request from "Friends of the Friarage Hospital" to help publicise a petition on the issue. The Council resolved to publicise the petition via website and social media.
232.1819	Twinning – to consider a request to formalise the Declaration of Friendship between Bedale and Azay-sur-Cher by way of a Charter. The Chair of the Twinning Association, Pam Hallett, gave a short presentation on the history of the Twinning Association, how the partnership with Azay-sur- Cher was formed, and the current relationship. Ms Hallett asked for Council



support to formally validate the Twinning via a Charter, a copy of which was handed out to Councillors. The Council **resolved** to approve the signing of the Charter. 233.1819 Bedale Town Council Elections – to note the forthcoming elections on 2nd May 2019 for all seats on Bedale Town Council and to note the ways in which Nomination papers can be obtained and should be returned. The Clerk confirmed that nomination papers were available from the Town Council office now. He added that the forms had to be hand delivered (by self or nominated person) to Stone Cross, Northallerton between 20th March and 4pm on 3rd April 2019. **Planning Applications and Decisions:** 234.1819 Applications: 18/02746/FUL and 18/02747/LBC Alteration and change of use of former first floor office space to provide three residential apartments at 23 Market Place, and listed building consent for this Council resolved to support the application 19/00148/FUL Change of use of part of car park for the siting of bin stores for apartments at 4a Bridge Street Council resolved to support the application 19/00288/ADV and 19/00291/LBC Installation of new lighting and signage to the front of the public house and advertisement consent at the Three Coopers, Emgate, and listed building consent for this

How you can help to tackle Modern Slavery and Human Trafficking

(From NYP website)

Modern Slavery and Human Trafficking are exploitative crimes and are growing issues which affects men, woman and children.

Victims are viewed as a commodity to be traded or exploited over and over again. This may be for use in criminal purposes, forced labour, domestic servitude or for sexual exploitation.

The National Crime Agency reported that in 2017, 5,145 potential victims of modern slavery were identified, a 35% increase on the previous year.

However, due to the hidden and secretive nature of the crime, it is thought that there may potentially be tens of thousands of victims in the UK.

Cases of modern slavery have been found all across the country, at car washes, construction sites, in agricultural industries and in food processing.

Victims are payed little and forced to put up with poor living and working conditions.

Some are forced into sex work or into the production of cannabis, with their freedom of movement removed from them, as their passports and papers are taken away, effectively trapping them into the situation.

We need to highlight the fact that this crime is happening here in North Yorkshire and we are appealing to members of the public that if they see something suspicious, they must report it.

Detective Inspector John Paul Freer, of North Yorkshire Police's Safeguarding and Vulnerability Unit, said: "Modern slavery and human trafficking are not confined to major cities.

"This issue affects all parts of the UK – it's in our towns and cities, in our rural communities and we should not assume that North Yorkshire is not touched by this growing offence.



"We know from national figures that modern slavery and human trafficking are on the increase, but the nature of these crimes means that victims are hidden and controlled. This makes it very hard to spot or recognise, particularly regarding victims of sexual exploitation, forced labour or domestic servitude. "It may be that as you legitimately go about your business, you inadvertently come into contact with individuals who are being exploited.

"These include those who work in the food and restaurant industry, hotels and accommodation letting, farming and other rural businesses, and car washes and nail bars.

"If you think an individual or a group of people are being exploited, please do the right thing and contact North Yorkshire Police on 101.

"If there is an immediate threat, always dial 999.

"You can also contact the Modern Slavery helpline on 08000121700. It is open 24 hours a day, 7 days a week.

There is also the option to pass information anonymously to Crimestoppers on 0800 555111. "The most important thing is to take action and tell someone. This will ensure that these demeaning, degrading and exploitative crimes are dealt with by the police and our partner agencies and the victims are supported."



How to recognise the signs of modern slavery

Whilst slavery can be hard to identify, there are some indicative signs you can be aware of:

PHYSICAL APPEARANCE – Victims may show signs of physical or psychological abuse, look malnourished or unkempt, or appear withdrawn

ISOLATION – Victims may rarely be allowed to travel on their own, seem under the control and influence of others, rarely interact or appear unfamiliar with their neighbourhood or where they work

POOR LIVING CONDITIONS – Victims may be living in dirty, cramped or overcrowded accommodation, and/or living and working at the same address

FEW OR NO PERSONAL EFFECTS – Victims may have no identification documents, have few personal possessions and always wear the same clothes day in day out. What clothes they do wear may not be suitable for their work

RESTRICTED FREEDOM OF MOVEMENT – Victims have little opportunity to move freely and may have had their travel documents retained, e.g. passports



UNUSUAL TRAVEL TIMES – They may be dropped off/collected for work on a regular basis either very early or late at night

RELUCTANT TO SEEK HELP – Victims may avoid eye contact, appear frightened or hesitant to talk to strangers and fear law enforcers for many reasons, such as not knowing who to trust or where to get help, fear of deportation, fear of violence to them or their family.

If you see something suspicious please report it. Together we can break the cycle of exploitation.
