from “as a playing field and Public Park for recreational purposes and for no other purpose”, as per clause 1 of the 1988 lease of Bedale Park as amended in 1992.”

- 063 New tree and bench in Bedale Park** – to consider purchasing and installing a whitebeam tree, of about 18cm girth and 5m height, for installation at the corner of Bedale Park, at the Bedale Hall car park end of the footpath parallel to North End. The cost of the tree would be c. £1,600, and the tree would be surrounded by the hexagonal memorial bench which has already been approved (item 012.1920) and constructed.
- 064 Scouts and Guides Community Festival** – to consider a request from Bedale Scouts and Guides for a Section 137 donation of £360 to cover traffic management of the road closure for their 2020 festival, taking place on Sunday 7th June.
- 065 Bedale sign** – to consider a request from Bedale Twinning Association to support the production of a replacement sign to go on the millstone near St Gregory’s Church, with a Yorkshire rose and the words “BEDALE / Twinned with Azay-sur-Cher”. The cost of this would be not in excess of £400, and the Association is prepared to make a donation of £300 towards this cost
