	Declarations of interest were received from Cllr Barningham for agenda item 082.1920, planning item 19/01717/FUL.
072.1920	Apologies and reasons for absence:
	Apologies were received and accepted from Cllrs John Howe and John Noone.
073.1920	Minutes of the Town Council meeting held on 12th August 2019:
	The Council RESOLVED to approve the minutes as a true record of the meeting, and they were signed as such by the Chair.
074.1920	Updates from minutes (not covered elsewhere on the agenda)
074.1	VE Day 75 – to note the booking of the "Gershwin Gang" swing band for this event, and consider other activities for the evening:
	The Clerk informed Council that the swing band had been booked, and councillors
	discussed other ideas for the event stallholders to dress in 1940's costume, arranging period vehicles to be on site, and organising window displays in the town. Any further suggestions to be forwarded to the Clerk.
074.2	Tree and bench – to note progress on the installation of the whitebeam tree and bench in Bedale Park:
	The Clerk confirmed that the planting of the tree and installation of the bench was
	imminent, hopefully in the next two weeks. Also, that the tree next to the youth shelter was to be pruned to enable CCTV to have a clear view of the shelter.
075.1920 075.1	Reports of recent activity Reports from external body meetings attended by Town Councillors:
	Cllr Macklewain-Hallett thanked the Council on behalf of the Twinning group for
	helping to install the new Bedale sign; she said there was currently a walking group
	from Azay-sur-Cher staying at Crakehall and visiting the Bedale area. Also, that there had already been a two-way exchange between a pupil at Bedale High School and
	Azay-sur-Cher during the summer holidays.
	Cllr Barningham provided and update from the Bedale and Villages Community Forum AGM, noting that BVCF had approved donations of £2k for the Bowling Club, £1k for
	the Bonfire, £2.5k for the Youth Venue and £500 towards the UCI cycle ride.
	Cllr Barningham also noted that the BTC-funded defibrillator at Bedale Hall had been partially installed and would be completed shortly.



	Cllrs Hallett and Macklewain-Hallett had attended the Colburn Civic service. Cllr Coates had attended a RAFA meeting. Cllrs Ingram and Young had attended the Joint Burial Authority meeting. Cllrs Mollard and Young had attended a Christmas meeting where Christmas lights and the Christmas Festival was discussed. Cllr Mollard had attended a YLCA Joint Executive Board meeting. Cllrs Barningham, Hallett and Mollard had attended the BVCF AGM. Cllr Macklewain-Hallett proposed that instead of simply listing meetings attended, that Councillors should report on discussion and decisions from these meetings which would be of interested to the town council and the Bedale community. This information to be reported to the Clerk ahead of the next town council meeting, to be circulated along with the agenda. The Council RESOLVED to approve this proposal, to commence with immediate effect.
75.2	Reports from District/ County Councillors: NY County Councillor Weighell confirmed that he had attended meetings on issues including vehicle activated signage, the UCI World Road Championships, and the clean-up operation in Swaledale and Wensleydale following the floods. Also, that the Bedale Extra Care scheme had been amended and was shortly to be put forward for public discussion. District ClIr Barningham confirmed that UCI road closures in Bedale would be between 11 – 3:45pm, with bin collections being moved back a day to the 26 th September. He also reported that: Hambleton DC had proposed a new crematorium locally and were currently carrying out a feasibility study; Lamett Hospital in Thirsk had been donated along with £90k to the district council and would become a hospice; Bedale Leisure Centre was to get a mobile phone app which could be used for bookings; the Parish Liaison Meeting minutes were available online; and that Hambleton DC would be putting together a £30 million property portfolio to help boost future finances, with the hope that an income of £400-800k would be achieved by 2022-2023.

079.1920	Car Boot Sales concessions – to consider the length of time for which to advertise the Car Boot Sale sole caterer and ice cream provider tenders, and the deadline for applications:
	The Council RESOLVED that the new catering contracts should be two years (2020-21) and the deadline for tenders be the end of October which will allow this to be included in the November agenda for discussion.
080.1920	Town Council archives – to consider engaging a sessional worker and document removal company to look through the archives and sort them for re-filing or destruction in accordance with the Council's retention policy and statutory requirements:
	The Council RESOLVED to engage a worker and document removal company
081.1920	Car Boot Sale – to note an injury to a member of the public at the 24 th August car boot sale, and remedial action taken to prevent further incidents: The Clerk informed the Council that on 24 th August a MoP stumbled on a pothole in the park and damaged her ankle. The ambulance was called which took her to hospital for assessment. No further contact from the injured party had been received. An Accident Report was completed at the scene by the Car Boot Sale Manager, and the pothole had been made good before the next car boot sale.

	19/01705/FUL – Conversion of existing garage to form WC/utility and store, and erection of new shed, at 15 Iddison Drive.
	The Council RESOLVED that it has no objection to the application 19/01733/RPN – Notification of prior approval for a proposed larger home extension to rear to extend beyond 6m beyond the rear wall, maximum height measured from natural ground level 3.65m and height at eaves from ground level 2.4m at Oak Tree
	Close. The Council RESOLVED that it has no objection to the application with a comment that there should be no windows on the Burrill Road side of the extension
	19/01778/FUL – Proposed two storey extension, including internal layout alterations and refurbishment of existing facilities and improvements to parking and landscaping at Glebe House Surgery.
	The Council RESOLVED that it had no objection to this application, which will provide much-needed extra capacity at the surgery, but also to submit the following comment:
	"The council does however wish to comment that the extra six parking spaces provided do not seem to be adequate for the extra footfall of staff and users which this
	development will attract. This would then have a knock-on effect to Firby Road, where



	traffic is already heavy and problematic. The town council would appreciate it if planners considered asking NYCC Highways to instate double yellow lines on Firby Road to avoid any escalation of the already difficult traffic conditions there."
