To note an appeal to the Secretary of State against the refusal of application 19/01511/FUL for 14 dwellings at Bedale Allotments, and to discuss whether to make any comment to the appeal beyond those already submitted as a statutory planning consultee. [Clerk's note: The Town Council had no objection to the plan on either occasion it was discussed, but noted: its disappointment at the lack of affordable housing; concerns over the creation of a 'ransom strip'; and a positive response to the design and layout of the proposed development.]

Also to note planning decisions made by principal authorities since August's meeting

- 063 Waste bins at Bedale Park to consider a suggestion from a MoP that the Town Council purchase two waste bins for the area of the new play/fitness area in Bedale Park
- 064 Wildflowers on verges to consider a request from a parishioner that the Town Council gives over some of the grass verges it manages to wildflower planting, and/or lobbies NYCC to do the same on the bypass, Leyburn Road and Masham Road
- **065 Church clock** to consider renewing the service agreement with Smith of Derby Ltd for the servicing of the church clock, with the options of a six-year contract for £953, a three-year contract at £505, or a recurring annual contract at £187 p.a.
