- 22.154 Tree surgery** – noting the tree survey undertaken on 7th February, to consider authorising works to seven trees assessed as “urgent” at a cost of £1,480, and further decay investigation on two more trees at a cost of £500.
- 22.155 Asset register** – ahead of the annual insurance renewal and end of year processes, to approve the Council’s current asset register as circulated.
- 22.156 Bridge Street toilets** – to make a decision about the future of this facility, noting: the results and feedback from the recent online survey; that Hambleton DC does not have any interest in the building; and, that the male and female units have been locked shut for three months with no comments or complaints received.
- 22.157 Skipton Building Society** – to resolve to open a new account at this facility, with Cllrs Coates, Hallett, Howe, and Mollard as signatories, and that the balance of the existing account *****4576 be transferred to this new account.
- 22.158 Verges at South End / Masham Road** – to consider installing wooden posts on the verges between 46-64 South End, and the verge opposite Mowbray School, to prevent the verges being churned up by inappropriate parking, at a cost of £1,140.
