- 26.70** **“Bedale Spotters”** – to consider funding, under Section 137 of the Local Government Act 1972, some or all of the cost, not exceeding £900, of an 8-page A6 leaflet to enhance the experience of visiting Bedale Park for 3-9-year-old children
